EXECUTIVE SUMMARY

Project Overview

In February 2000 the Alberta Infrastructure School Facilities Branch engaged Carruthers & Associates Architects Inc. to investigate and report on the physical condition of 23 schools in Calgary under the jurisdiction of the Calgary Board of Education. We are now pleased to present the results of our investigations, in the form of charts as specified by Alberta Infrastructure.

1972 Concrete slab, concrete block frame walls, OWSJ

The original 1964 building boiler plant consists of two Peerless hot water boilers which also supplies heat to the 1968 addition. System operates satisfactorily but should be considered for replacement due to age.
