EXECUTIVE SUMMARY

Project Overview

In February 2000 the Alberta Infrastructure School Facilities Branch engaged Carruthers & Associates Architects Inc. to investigate and report on the physical condition of 23 schools in Calgary under the jurisdiction of the Calgary Board of Education. We are now pleased to present the results of our investigations, in the form of charts as specified by Alberta Infrastructure.

Construction History

Original: 1971, 3226.3 m.² 18 classrooms, washrooms,

offices, Gymnasiums.

Portables 1985 400 m2, 4 classrooms

Evaluation Date: March 29, 2000

Building Summary

Combustible Construction - Concrete floor slabs timber frame, concrete block partitions, brick exterior walls, wood deck roof non-sprinklered

Mechanical: 2 boilers at 2,880 MBH each supply heat for entire school. Units operate well, but due to age, boilers can be anticipated to have more problems in the future..

Summary of Observations and Recommendations

Classroom millwork requires refinishing
Washroom finishes require repair and replacement.
Parking areas require curb cuts for handicapped access
Carpeting is worn and should be replaced
Gym floor requires refinishing.
Barrier free access to be provided.

Mechanical: School requires some work on sprayed coil system and possible replacement of cooling.

Electrical The building requires upgrades in a few all areas with emphasis on Fire Alarm, Emergency lighting and exit lighting.
