EXECUTIVE SUMMARY

Project Overview

In February 2000 the Alberta Infrastructure School Facilities Branch engaged Carruthers & Associates Architects Inc. to investigate and report on the physical condition of 23 schools in Calgary under the jurisdiction of the Calgary Board of Education. We are now pleased to present the results of our investigations, in the form of charts as specified by Alberta Infrastructure.

Construction History

Original: 1954, 2131.8 m.² 12 classrooms, washrooms,

offices, gymnasium

Addition: 1962, 587.7 m.² Home Economics, Industrial Arts

Evaluation Date: April 3, 2000

Building Summary

1954: Wood frame walls, wood beams and wood deck roof, stucco and clapboard cladding. North(centre) block is concrete structure with block infill, wood roof and terrazzo floor

1962: Wood and concrete floor construction, block and wood frame wall construction, open web steel joists, wood roof decking.

Central low pressure steam boiler with unit ventilators.

Summary of Observations and Recommendations

No dedicated outdoor playing fields-fields of Ernest Manning are used Surface drainage requires significant work.

Asphalt needs refurbishment

All exterior finishes and trims require refurbishment

Exterior windows and doors require replacement.

Interior flooring requires replacement.

Interior walls require refinishing and painting.

Interior fire compartments need proper fire doors.

Interior millwork requires extensive refinishing.

Washroom finishes require redoing

Barrier free access to be provided throughout

Boiler to be replaced

Ventilation to be upgraded

Woodworking needs exhaust system

Building controls need upgrade.
